## **1.0 Purpose**

The purpose of this paper is to request for Board of Management (BOM) to approve budget proposal for Expanding and Monitoring State DCP Champion 2019.

## **2.0 Background**

- a. A special meeting chaired by KSN and attended by all State Secretariats on the 17<sup>th</sup> October 2016 has agreed on the establishment of State DCP Champion (previously known as 1 State 1 DCP Champion). This initiative is going to be a state driven initiative with KPKT, PAM and MPC providing the tools and programs towards the establishments of champions.
- b. One of the local authority that is being closely monitored by MPC is Kota Kinabalu City Hall (DBKK). Several workshops and focus groups meeting was held by DBKK throughout 2017-2018. 2018 marked the best year for DBKK as it was the first local authority (among those involved in State DCP Champion Program) to launch a Dealing with Construction Permits Manual.
- c. MPC has received several request to expand the program to other local authorities. In 2019, MPC will initiate the program with Langkawi and Penampang, as well other local authorities, based on request. The expected outcome of this program is the streamlining of procedures and guidelines to enhance efficiency of dealing with construction permits in Malaysia.
