1.0 Purpose

The purpose of this paper is to request approval from Board of Management (BOM) for the project on **Good Regulatory Practices in Malaysia : High Level Engagement**.

2.0 Background

In the Eleventh Malaysia Plan 2016 – 2020 Chapter 8 Strategy A2 stated that “Comprehensive and integrated governance reforms will be pursued to ensure a thriving and competitive environment for the services sector. **The National Policy on the Development and Implementation of Regulations (NPDIR) to modernize the current regulatory regime will be fully implemented to include states and local governments.** Malaysia is about to operationalize Regulatory Impact Analysis (RIA) into the policy making process of Malaysia.

MPC also has been mandated by the Government in Services Sector Blueprint to undertake initiative on Sectoral Governance Reform. The main goal of sectoral governance reform is to create efficient and enabling policy environment that nurtures a thriving and competitive services sectors. One of the two initiatives that MPC is required to carry out is accelerating and expanding NPDIR implementation.

Political covers for the better networking between MPC and states in creating the awareness about the importance of Good Regulatory Practices (GRP). Instead of getting buy in from the states, MPC also needs to facilitate in introducing the best practices in rule making process to a more open and transparent process in regulatory development and implementation. The work progress will be reported to GRP Steering Committee.
