1.0 Purpose

The purpose of this paper is to seek approval from MPC Board of Management (BOM) to conduct impact study of COVID-19 and moratorium on Productivity toward selected sub-sector (9 Nexus) with the total estimated cost of RM18,000 utilising the SPN budget.

2.0 Background

Since the Covid-19 outbreak was first diagnosed, it has spread to over 150 countries including Malaysia. The pandemic is having a noticeable impact on global economic growth. Estimates so far indicate the virus could trim global economic growth by at least 0.5% to 1.5%, but the full impact will not be known until the effects peak. This pandemic will have devastating effects on the Malaysian economy from both external factors (global supply and demand shocks) and domestic factors particularly with four-week Movement Control Order (MCO). Businesses and services deemed to be non-essential were temporarily closed and this will affect all sectors in Malaysia.

This study will provide the overview on how the pandemic may affecting the businesses in terms of their productivity across the economic selected sector involving manufacturing, services and agriculture during the recovery movement control order (RMCO).
