### **1.0 Purpose**

The purpose of this paper is to seek the approval of MPC's Board of Management (BOM) to Private Healthcare Productivity Nexus (PHPN) Coordinator with the approve budgets for appointing Nexus Coordinator for PHPN.

### **2.0 Background**

The Productivity Nexus for Private Healthcare was established to ensure effective implementation of sector specific productivity initiatives and work closely with industry on the ground. The initiatives under the Productivity Nexus is expected to better support and equip local enterprises to adopt technological advancements and identifying the opportunities of the sharing economy through stakeholder's needs assessment and benchmarking with global best practices.

Therefore, in overseeing and supervising the progress of the Nexus, Governing Committee is established. This Governing Committee comprises of representatives from associations and government agencies in relation with Private Healthcare industry. All initiatives identified were aimed at solving specific root causes in the challenges faced within the private healthcare and at the same time were aligned to the five thrusts in Malaysia Productivity Blueprint (MPB).

These initiatives are divided into three (3) Focus Group (FG) namely

- FG 1: Workforce & Performance
- FG 2: Technology & Innovation
- FG 3: Regulatory

The appointment of Nexus Coordinator is to consult, and monitor projects approved by the Nexus Governing Committee as well as support the Chairman and PHPN team in oversee the overall implementation of all initiatives under the respective Productivity Nexus. Terms of reference for the nexus coordinator are attached in **Appendix 1**

### **3.0 Objectives**

- a) To assist the PHPN in consulting and monitoring projects approved by the Nexus Governing Committee;
- b) To support the Chairman in oversee the overall implementation of all initiatives under the respective Productivity Nexus;
- c) To support the Chairman in governing the nexus and implementing the

productivity initiatives and activities;

- d) To provide necessary professional inputs to support the implementation of all initiatives;
- e) To prepare the minute of meeting and circulated within seven (7) working days from the date of the meeting;
- f) To attend relevant meetings and discussions with stakeholders within the Selangor state and any other location(s) as required;
- g) To prepare relevant presentation materials for relevant workshop(s) or meetings as scheduled;
- h) To attend the project progress review sessions with MPC and its international expert; and
- i) To provide any recommendations per own area of expertise or knowledge or reference on the best practices and new developments in other countries.


