1.0 Purpose

The purpose of this paper is to inform the Board of Management (BOM) on the changes of detailed costing for Advocating e-Shared Prosperity Organisation (eSPO) Platform which has been approved on 22 April 2021 (Keratan Minit Bil. 434/2021).

2.0 Background

e-Shared Prosperity Organisation (eSPO) is an online platform that issues electronic acknowledgement certificate to the organization that successfully implemented Productivity-Linked Wage System (PLWS). As a strategic enabler that contributed to the wealth creation and wealth sharing, the importance of the PLWS is clearly mentioned in MPB 2017, SPV 2030, Bank Negara Report 2018 and the coming National Human Resource Blueprint (NHRB).

The main objective of eSPO is to increase the take up rate of PLWS adoption via acknowledgement certificate. eSPO is launched on 17 December 2020 by YBhg. Dato' Sri Norazman Ayob, Deputy Secretary General, MITI. To expedite eSPO acknowledgement for year 2021, a programme on advocating on eSPO is needed to advise, facilitate, and encourage industry players to be acknowledged.

3.0 Objectives

- i. Raise awareness about e-Shared Prosperity (eSPO) platform; and
- ii. Help businesses evaluate and utilize e-Shared Prosperity Organisation platform.

4.0 Programme Implementation

The programme is proposed to be conducted by a few moderators for five (5) main industry sectors namely Manufacturing, Services, Construction, Agriculture and Mining & Quarrying.

Another programme to be organized is strategic session and engagement with stakeholders on PLWS and eSPO future activities.


