TERMS OF REFERENCE (TOR) TECHNICAL EXPERT FOR TOURISM PRODUCTIVITY NEXUS (TPN): INTEGRATED CONCEPTUAL FRAMEWORK ON SUB-INDUSTRY ADVENTURE TOURISM

1.0. Purpose of the Assignment

The purpose of this assignment is to appoint a technical expert for Tourism Productivity Nexus (TPN) project to produce an integrated conceptual framework on sub-industry Adventure Tourism.

3.0. Scope of Work

3.1. Review of Literature on the Subject Matter

- 3.1.3. Analyse conceptual frameworks from the industry experts, maximum of 4 frameworks.
