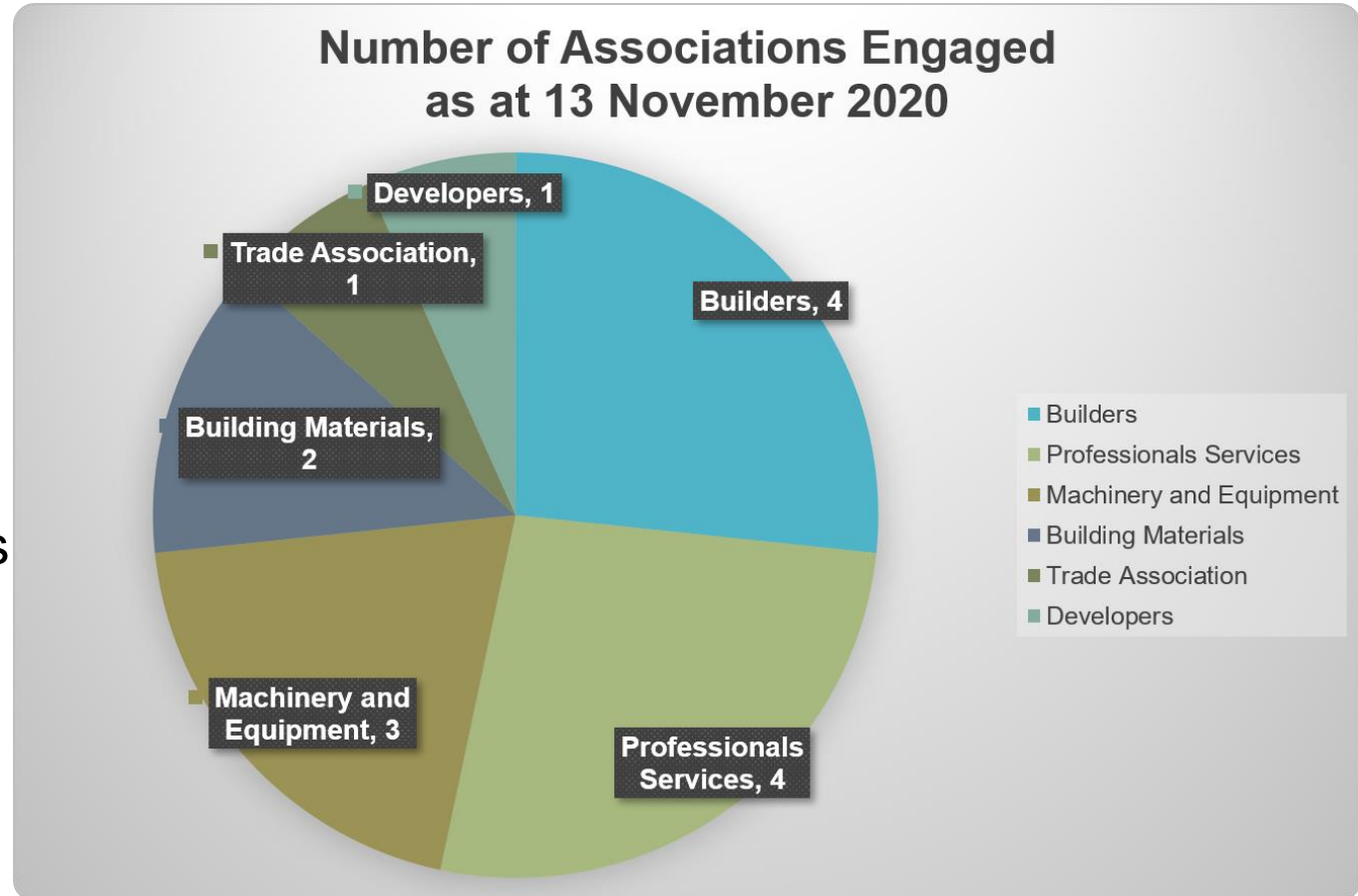

OBJECTIVE

To obtain **feedback** from the industry on the Draft Proposal on **Enhanced Policy for Buy Malaysian Products First**.

BACKGROUND

- TWGCG received from industries on Buy Malaysian Products First policy, with its main objectives to:
 - Boost the local demand for Made in Malaysia products; and
 - Help local economies to get back on their feet and ensure competitiveness of our local producers.
- A total of 3 WG meetings has been conducted since July 2020 (chronology as per Appendix 1)



DEFINITION OF MALAYSIAN PRODUCTS

- **Current definition by KPDNHEP – Goods and materials:**

- a) “Produk mestilah dikilangkan di Malaysia dan mengandungi sekurang-kurangnya 51% bahan / kandungan tempatan dan produk-produk yang dikeluarkan hendaklah melibatkan aktiviti proses pengilangan manufacturing activity”

TWGCG (Meeting No.2/2020 and Meeting No.3/2020): Feedback on the current definition received from:

- **Construction industry:**

- a) To include 60% tangible (building raw material and 40% intangible). Tangible accounted for construction materials and construction & machinery incorporated in the construction of the building whilst intangibles accounted for services; professionals services and rental of machinery and equipment.
- b) To add into the definition “..must be manufactured in Malaysia regardless of the source of raw materials”.

- **FMM – Manufacturing Industry:**

- a) To impose 40% local content and to take into account ASEAN material costs, direct labour costs, direct overhead costs and profit in addition to the requirement for applicant to fulfill either one of the following pre-conditions:
 - i. Manufacturer to be registered under the Industrial Coordination Act (ICA) - Malaysian Investment Development Authority; OR
 - ii. Local council license to have the wording “membuat / memproses” to indicate that proper manufacturing process exist.

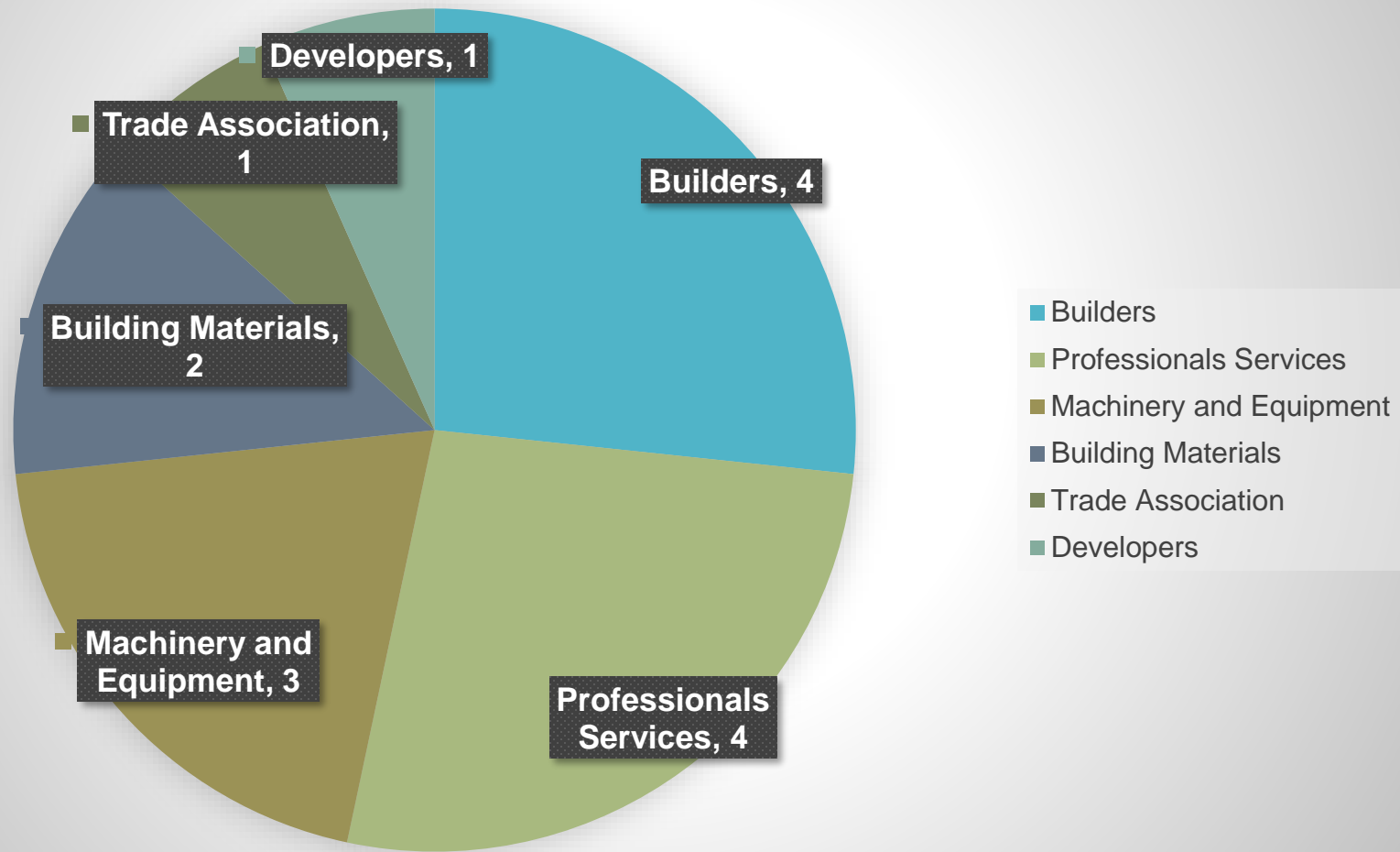
