First of all, I would like to thank the Malaysia Productivity Corporation (MPC) and the Secretariat of the Private Healthcare Productivity Nexus (PHPN) for inviting me here to officiate the launching of the ***Handbook on Technical Design Reference for Disaster Preparedness In Setting Up New High-Rise Private Hospital and CEO Forum on My Health Data Warehouse (MyHDW)***, which is held ***virtually*** during this time of COVID-19 pandemic.

Ladies and Gentlemen,

4. Malaysia generally has an efficient and widespread healthcare system, operating in a two-tier: public healthcare system and a co-existing private healthcare system

The Government places high importance on healthcare **productivity** for socio-economic growth; and recognises the way forward would be **to collaborate and work together** through a healthy private-public partnership to enable us to face the challenges ahead and **keep Malaysia competitive, productive and safe**.

Ladies and Gentlemen,

6. The Malaysian Health Data Warehouse (MyHDW) is important for us and our country to meet the diverse needs of timely health information provision and management. It acts as a platform for the standardization and integration of health data from a variety of sources – from both public and private hospital or clinics' health information records. Its main objective is to reduce the burden of data collection and processing.
7. The use of MyHDW is crucial to support the Ministry of Health to collect and integrate all information that will be available in the 'right time' and provide timely information on the nation's state of health information.
8. The current pandemic forces us to live in a new norm and technologies are becoming even more important in our daily function. Anticipating the need to act fast and timely, I would

encourage all private hospitals in Malaysia to send health information to MyHDW through online submission, so that the system will utilize its data analytics capabilities more efficiently. In today's forum, I believe you will gain insights on how MyHDW work from our PIK (Pusat Infomatik Kesihatan) team.

Ladies and Gentlemen,

I am pleased to see that the private-public partnership in this private healthcare sector really works and the initiatives through the collaboration between Private Healthcare Productivity Nexus (PHPN), MPC and MOH-CKAPS (Cawangan Kawalan Amalan Perubatan Swasta) has achieved quite a number of milestones.

Aside from the initiative on MyHDW, the collaboration between PHPN, MPC and MOH with support from various technical agencies (BOMBA, NADMA), and technical professionals have established four (4) guidelines for business to refer to in their application process to build a new private hospital. The guidelines have been made available online MOH website to provide an easy reference guide to the application process for constructing new private hospitals.
11. The “**Handbook on Technical Design Reference for Disaster Preparedness In Setting Up New High-Rise Private Hospitals**” is the 5th handbook produced through this collaboration. I hope businesses will benefit from this handbook which is intended to provide a clear guide and help private hospital operators to submit a quality submission for a new high-rise private hospital in future.


Ladies and Gentlemen,
