

Adjusted Membership Contributions for 2021

This memo is a follow-up to the 62nd Session of the Governing Body (GB) held on 8 June 2020, specifically regarding the apportioned membership contributions for the 2021–2022 biennium.

The relevant decisions on this matter are as follows:

- The Secretariat's proposal to allocate USD3 million from the unappropriated surplus to the membership contributions was not approved.
- The budget size/total membership contributions for FY2021 will remain at USD11,986,035.

Member countries are also advised that the FY2021 membership contributions will be subject to adjustments due to the admission of Turkey. This was communicated previously by the Secretariat in conjunction with the Revised Budget for FY2020 and approved by the Directors on 8 May 2020.

The assessment for Turkey for FY2020 following the current contribution formula is USD771,057. This amount will be apportioned to member countries based on their ratios of contributions for FY2020, except for those members paying the minimum contributions. The membership contributions for FY2021 after incorporating the adjustments arising from the contributions of Turkey are shown in Table 1.

For reference, the applicable ratios for members for FY2021 based on the current formula are provided in Annex 1.

Under the biennial budgeting system, the total membership contributions for FY2022 and the allocations for each member will follow the amount for FY2021, unless the Governing Body decides otherwise.
