Introduction

2. Responsibilities of Service Provider on Outcome of Deliverables:

- Provide training on the three (3) main components of the Productivity-Linked Wages System (PLWS) available in the eSPO system to companies/ organizations online.
- For successfully registered cases, Service Provider is required to generate and send soft copy of eSPO Certificate to the registered company.
- Submission of weekly registration tracking report
- Final report presentation to PLWS Unit, MPC in July 2021.
- To achieve minimum of 2,000 participated eSPO companies in a period of 2 months
