TERMS OF REFERENCE (TOR)

LEAD FACILITATOR FOR ARTIFICIAL INTELLIGENCE FOR SMEs

1.0 Purpose of the Assignment

The purpose of this assignment is to appoint as lead facilitator for Artificial Intelligence for SMEs (AI4S)

2.0 Scope of Work

- 2.1 Oversee and monitor the implementation of the whole project
