TERMS OF REFERENCE FOR SPEAKER, FACILITATION AND PRODUCE WRITE UP ON GRP TOOLS

1. BACKGROUND

- 1.1. Regulations are requirements imposed by governments that influence the decisions and conduct of businesses, other organisations and consumers. It is inconceivable to think of a modern economy functioning without regulation. Good regulation minimizes compliance costs and distortions to investment (efficiency), while still achieving its objectives (effectiveness) and delivering benefits which exceed the costs it imposes (appropriateness).
- 1.2. However, regulations also impose costs on businesses. When regulation is poorly designed, excessive, needlessly complex, duplicative, or formulated without adequate transparency or consultation, these costs are unnecessarily burdensome.
- 1.3. Projects under the Forging a Robust Ecosystem programme will undergo the process of identifying unnecessary regulatory issues that give burdens to the businesses, identifying potential issues according to the real cases and data, market information, best practices and produce recommendations to the related regulators to fasten the process of doing business and economy recovery of Malaysia.
